2022 CANDY CANE GALA RAFFLE RULES

1. Tickets are sold online through Ticket Tailor online ticketing site, along with table purchases for the event until Friday, November 25th. On December 2, 2022 tickets will be available in-person at the Candy Cane Gala event at the BMO Centre via Moneris and cash payments.
2. Ticket purchasers must be 18 years of age or older, reside in Alberta and must use a major credit card or Visa Debit when buying online via Ticket Tailor or in-person on December 2nd. Credit cards used for payment must have an Alberta address. A checkbox will be required when purchasing on Ticket Tailor to confirm they are 18+ and reside in Alberta. Cash payments will be accepted December 2, 2022 in-person only.
3. Tickets will be available online through Ticket Tailor in advance of the event and in-person at Candy Cane Gala on December 2, 2022 and sold at a rate of:
 - 400 @ 1 for \$100 = \$40,000
4. Physical tickets will be mailed out if purchased in advance online and purchasers will receive a physical ticket if they purchase at the event on December 2, 2022.
5. ACHF staff and their immediate family members are prohibited from purchasing tickets.
6. ACHF volunteers working at this event may only purchase a ticket from another seller while on a break from their duties, and only from the "buying" side of the raffle selling station/area/table.
7. All ticket sales are final. There will be no refunds.
8. The cost of raffle participation is not considered a charitable donation by the Canada Revenue Agency and is not eligible for a tax receipt.
9. Ticket sales will end on Friday, December 2, 2022 at 8:30 pm.
10. The winner will be determined by a random draw from a raffle barrel.
11. The draw will be conducted on Friday, December 2, 2022 at 9:00pm and the winning ticket will be announced onstage at the Candy Cane Gala event at the BMO Centre.

12. One executive member of the Alberta Children's Hospital Foundation, and one member of the public who did not purchase a ticket will be present to witness the draw.
13. The person(s) drawing the winning number must not hold a ticket for that draw.
14. The person making the draw must have their arm be bare of clothing below the elbow and they must look away from the barrel while making the draw.
15. One grand prize will be awarded: Las Vegas retreat for 8 including a private Air Partners jet, transportation to and from the hotel, and overnight accommodations, donated by Air Partners.
16. If the winner is not present for the draw, they will be contacted by the phone number provided on the ticket to notify them of their winnings and proper delivery of the prize determined.
17. Winner will provide their winning ticket and present their photo ID to ACHF upon claiming the prize.
18. By purchasing a ticket, the winner consents to having his/her name, winning numbers published.
19. The prize is non-refundable and non-transferable. There are no cash alternatives for the prize.
20. Travel is to be completed by Dec. 31, 2023 and available dates are subject to aircraft and accommodation availability.
21. In the event that the prize is not claimed within three months from the draw date, and after all reasonable attempts have been made to contact the winner, ACHF will apply to the AGLC to have the prize, or value, donated back to their own approved use of proceeds.
22. In the event that the winning ticket has more than one name on it, the prize shall be awarded to only one of the individuals, with the first name on the ticket deemed the official winner. ACHF and AGLC are not responsible for any disputes which may arise between the different individuals whose names appear on the ticket.
